

#### **Child Support**

Child support is financial payments made for the child(ren) from one guardian or parent to the other, as determined by government-established guidelines.









### **PARENTING ORDERS**

Under Alberta law, both parents are deemed equal guardians unless specified by a court order. Parenting orders define who spends time with the child(ren) and who and how decisions are made for the child(ren).


Talk to a True North staff member for Parenting Order support. We can also help you create a safety plan for school and daycare routines!

Custody: Provides the parent(s) the legal right to make decisions and spend time with the child(ren).

Guardian: The person(s) responsible for the child's well-being who makes day-to-day decisions.

**Contact:** A non-guardian person(s), such as a grandparent, who spends time with the child(ren) but does not make decisions for them.

Access: Outlines the allotted time the child(ren) may spend with the parent without legal guardianship.



Joint Custody: Both parents have the legal right to make decisions (big and small) and spend time with the child(ren)


**Sole Custody:** One parent has the legal right to make decisions for the child in their custody

**Interm Parenting Order:** A temporary order that is put in place until the final parenting order is established (Calgary Legal Guidance, 2021).

### **PROTECTION ORDERS**

Protection orders help protect you and your child(ren) from unwanted contact. There are various types of protection orders for different situations. Talk to a staff member to help you through the application process.



Consider providing copies of your protection order to your child(ren)'s school and daycare, and local police services.

### ADDITIONAL PARENT RESOURCES

- Parenting After Separation eCourse: Free through the Resolution Services Learning Center
- Parenting After Separation for Families in High Conflict eCourse: Free through the Resolution Services Learning Center
- Maintenance Enforcement Program (MEP): Collects & enforces supports such as child support (Alberta Government, 2022-d)
- Duty Counsel (Legal Aid): Free legal representation & advice for Albertans who have not secured legal representation (*Pro Bono Law Alberta, 2022*)
- Mediation Services: Confidential & informal meetings between parents whose aim is to come to an agreement; not legally binding (Alberta Government, 2022-c)

### TYPES OF PROTECTION ORDERS

Emergency Protection Order (EPO): an urgent order one can apply for if a family member is harassing, threatening, or being violent (Calgary Legal Guidance, 2022). Police may apply this order, or you can apply at the Court of the King's Bench, Calgary Court House (Calgary Legal Guidance, 2022). Both parties must review the order after nine days of the order. *(Calgary Legal Guidance, 2022).* 

**King's Bench Protection Order:** a nonurgent order granted to persons experiencing family violence. Provides similar conditions as an EPO, with some variations.

**Restraining Order:** an order granted to a person experiencing unwanted/harmful behaviour (Centre for Public Legal Education Alberta, 2021-a) that stops the unwanted person from contacting you or coming to your home or workplace (Center for Public Legal Education Alberta, 2021-a). Apply at the Court of the King's Bench, Calgary Courthouse. (Centre for Public Legal Education Alberta, 2021-a)

**Peace Bond:** a nonurgent order in which parties agree to maintain peace, ordered by a judge. (*Centre for Legal Education Alberta, 2021-a*)

**Exclusive Possession Order:** a temporary order that allows the applicant exclusive possession of the family home and requests all others to vacate (Centre for Public Legal Education Alberta, 2021). Apply at the Court of the King's Bench, Calgary Courthouse. (Centre for Public Legal Education Alberta, 2021-a)

**No Contact Conditions:** Conditions outlined by a probation order or bail conditions, which may include that the Accused shall have no contact with the Survivor.

(Alberta Government, 2022-b)

**Clare's Law,** also known as the Domestic Violence Disclosure Scheme (DVDS), is a act in Alberta that giving people the right to know if their current or ex-partner has any previous history of violence or abuse.

Clare's Law states that Albertans who believe they are at risk of domestic violence have the right to get information about potentially harmful intimate partners.

People at risk can find out if their partner has a history of Domestic violence, Stalking or harassment, Breaches of No Contact Orders and Other Related Acts

#### Under Clare's Law, you have the right to:

- Make an application to the police requesting information about your current or ex-partner, because you are worried they may have been abusive in the past and believe they may pose a risk to you in future.
- Request information from the police about the current or ex-partner of a close friend, neighbour or family member, because you are concerned that they might be at risk of domestic abuse in future.
